TERMS AND CONDITIONS

A. Schedule to Conditions of Entry

1. <u>Organiser:</u>	GERBANG ALAF RESTAURANTS SDN. BHD 198001011565 (65351-M) ("McDonald's Malaysia")
2. <u>Contest:</u>	Jalan-Jalan McD #RoadTripChallenge
3. <u>Contest Period:</u>	The Contest starts at 00:00:00 on 10/12/2022 and ends at 23:59:59 on 31/12/2022. The Organiser reserves the right to end the Contest earlier or extend the Contest Period at its own discretion
4. <u>Eligibility:</u>	<ol style="list-style-type: none">1. This Contest is open to all individual legal residents of Malaysia aged 18 years and above as at the start of the Contest Period, and with a valid identification document and residential address in Malaysia.2. The Organiser shall reserve the right to request for evidence of identification documents.3. The employees of the Organiser, their immediate families, affiliates, subsidiaries, related agencies and suppliers and/or persons living in the same household are ineligible to join the Contest.
5. <u>Entry Method:</u>	<ol style="list-style-type: none">1. To participate in the contest, participants are required to have a registered McDonald's account linked to a valid e-mail address and mobile phone number. Participants must also have a registered account on Instagram and must set their privacy to "Public".2. Incomplete entry or entries that do not adhere to the rules and deadline will automatically be disqualified.3. The Organiser's decision on the winners list shall be final. The Organiser will not entertain any further correspondence or appeal.
6. <u>Entry Deadline:</u>	<ol style="list-style-type: none">1. All Entries must be received by the Organiser on or before 23:59:59 on 31/12/20222. All Entries received outside the Contest Period will be automatically disqualified.3. Incomplete entry or entries that do not adhere to the rules and deadline will automatically be disqualified.

7. **Contest**
Mechanism:

Contest Stamps

There are two (2) types of stamps that can be collected: Iconic Stamps and regular stamps.

The first thirty (30) participants in Peninsular Malaysia to collect all twenty (20) Iconic Stamps in their Jalan-Jalan McD Passport will each win a Prize.

All participants will be entitled to redeem a free McDonald's Voucher by collecting ANY 5 stamps (regular or Iconic), limited to a total of five (5) redemptions per participant throughout the Campaign.

To collect the stamps, participants must adhere to the following steps:

Step 1

Participants are required to obtain a Jalan-Jalan McD Passport by purchasing a Jalan-Jalan McD Bundle via Drive-Thru in any McDonald's Drive-Thru restaurant across Peninsular Malaysia.

Step 2

With a Jalan-Jalan McD Passport, the participants will be entitled to receive a stamp on their McD Passport when they make a purchase of RM20.00 or more via 'Order & Collect' with 'Drive-Thru' chosen as the collection method.

Upon receiving a physical stamp of an *Iconic Stamp*, participants will have to complete their participation by visiting the Jalan-Jalan McD entry submission webpage.

As for regular stamps, participants are only eligible to collect physical stamps on their McD Passports. In such instances, the participants are not required to proceed to Step 3 below.

Step 3

In the entry submission webpage for the collection of *Iconic Stamps*, participants are required to fill in their name, email address and contact number in the given fields. Subsequently, they are required to upload a photo of their purchase receipt as well as a photo of their Jalan-Jalan McD Passport with their latest tally of *Iconic Stamps*.

The first thirty (30) Participants to collect all twenty (20) <i>Iconic Stamps</i> during the Contest Period will be selected as winners. Each eligible winner will be entitled to one (1) Prize. 2. Participants can also redeem a McDonald's Voucher each time they complete a collection of any five (5) stamps. 3. For verification purposes, participants who have collected all twenty (20) <i>Iconic Stamps</i> are required to submit a video showing every page of their completed Jalan-Jalan McD Passport. The video must also include their Malaysian identity card (I.C.) 4. In determining whether an Entry is a valid Entry, the Organiser's decision shall be final and conclusive. 1. Introduction

- 1.1 This Conditions of Entry are to be read together with the Schedule to Conditions of Entry. To the extent that there is any inconsistency between these conditions of entry and the Schedule to Conditions of Entry, the Schedule to Conditions of Entry prevails. The Conditions of Entry and the Schedule to Condition of Entry shall collectively be referred to as the “Terms and Conditions”. Each capitalised term not otherwise defined herein shall have the meaning ascribed to such term in the Schedule to Conditions of Entry. Defined terms will be used singular or plural as the case may be.
- 1.2 The Organiser reserves the right in its sole discretion, without prior notice, and without any liability to any person, at any time to change the Terms and Conditions including to change the Contest Period, make Prize substitutions, cancel, terminate or suspend the Contest in whole or in part. In the event of any changes to the Terms and Conditions, Participants agree that their continued participation in the Contest will constitute their acceptance of the Terms and Conditions (as changed).
- 1.3 The Organiser’s decision on all matters relating to the Contest including judging and selection of winners will be final, binding and conclusive on all Participants, and no correspondence or appeals will be entertained.

2. Contest Entries

- 2.1 By submitting an entry to the Contest, Participants are deemed to have understood and agreed to be bound by the Terms and Conditions.
- 2.2 All costs and expenses incurred and/or arising from the participation in the Contest, including without limitation, telecommunications, network, Short Messaging Services, postal and all such other charges and out-of-pocket expenses as may be incurred by a Participant during or in connection with the Contest shall be borne by the Participant.
- 2.3 Proof of submission of an Entry is not proof of receipt, and the Organiser shall not be liable for any delay, lost, damaged and/or non-receipt of submissions. The Organiser is not responsible for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction, unauthorized access to, or alteration of, user or member communications, or any problems or technical malfunction of our telecommunications network or lines, computer online systems, servers or providers, computer equipment, software, failure of e-mail or players on account of technical problems or traffic congestion on the Internet.

3. Eligibility

- 3.1 Where the eligibility age prescribed in the Schedule to Conditions of Entry is below the age of eighteen (18), Participants are required to obtain the written consent (in

such form as may be prescribed by the Organiser), from their parents/legal guardians before participating in the Contest and submitting any personal information.

- 3.2 The Organiser may require a Participant to provide proof of eligibility to participate in the Contest including without limitation, identification documents, and the written consent of parents/legal guardians in the case of Participants below the age of eighteen (18) years.

4. Ineligibility

The following groups of persons shall not be eligible to participate in the Contest:

- 5.1 The following entries will be disqualified:

- (a) unclear, incomplete, duplicate, copies, illegible or incorrect entries; and/or
- (b) entries that violate the Terms and Conditions, any applicable laws and/or regulations.

- 5.2 In addition, the Organiser reserves the right to disqualify any Participant that:

- (a) undermines, has or attempted to undermine the operation of the Contest by fraud, cheating or deception; and/or
- (b) are not eligible or unable to provide proof of eligibility to participate in the Contest for verification by the Organiser when requested.

- 5.3 In the event of a disqualification after a Prize has been awarded, the Organiser reserves the right to demand for the return of the Prize or payment of its value from the disqualified Participant.

- 6.1 The Organiser, its agents, sponsors and representatives shall have no liability to any Participant who defaults in collecting the Prizes in accordance with the Prize Claim/Delivery Date in any respect whatsoever. The Organiser has the right to use and modify such materials or works in any way it deems fit without compensation to the Participant and the Participant waives all rights he or she may have in such materials or works.

9. Indemnity

Each Participant agrees to indemnify, release and hold harmless each of the Organiser, its holding, subsidiary or related companies as defined in the Companies Act 2016 ("Gerbang Alaf Restaurants Sdn Bhd"), directors, officers, employees, agents, sponsors and/or representatives against any and all losses, rights, claims, actions and damages (including special, indirect and consequential damages) arising from or incurred as a result of the Participant's participation in the Contest, acceptance of any Prize, and/or the use of the Participant's entry and/or likeness in connection with the Contest or violation of the Terms and Conditions,

10. Limitation of Liability

- 10.1 The Participant's participation in the Contest shall be at the Participant's own risk.
- 10.2 The Organiser, Gerbang Alaf Restaurants Sdn Bhd, its, directors, officers, employees, agents, sponsors and/or representatives shall not be liable to any Participant in respect of any loss or damage whatsoever which is suffered, including but not limited to indirect or consequential loss, or for personal injury suffered or sustained by the Participant arising out of or in connection with the participation by the Participant in the Contest, as well as the redemption and/or utilisation of any Prize won.
