3. Contest Period:	The Contest starts at 00:00:00 on 21/07/2022 and ends at 23:59:59 on 25/07/2022.
	The Organiser reserves the right to end the Contest earlier or extend the Contest Period at its own discretion
4. Eligibility:	 This Contest is open to all individual legal residents of Malaysia aged 18 years and above as at the start of the Contest Period, and with a valid identification document and residential address in Malaysia. The Organiser shall reserve the right to request for evidence of identification documents. Defined terms will be used singular or plural as the case may be.
