TERMS AND CONDITIONS

A. Schedule to Conditions of Entry

1. Organiser:	GERBANG ALAF RESTAURANTS SDN. BHD 198001011565 (65351-M)

2. <u>Contest Name:</u>	McDelivery #SelebHantarMeals (hereby known as the "Contest")
3. Contest Period:	The Contest starts at 12:00:00 on 04/05/2023 and ends at 23:59:59 on 10/05/2023.
	The Organiser reserves the right to end the Contest earlier or extend the Contest Period at its own discretion
4. Eligibility:	 This Contest is open to all individual legal residents of Malaysia aged 18 years and above as at the start of the Contest Period, and with a valid identification document and residential address in Selangor or Kuala Lumpur. The Organiser shall reserve the right to request for evidence of identification documents. Employees of McDonald's Malaysia, their immediate families, affiliates, subsidiaries, related agencies and suppliers and/or persons living in the same household are ineligible to join the Contest.
5. Entry Method:	 In order to participate in the Contest, participants must adhere to the following criteria: a. Order McDelivery via McDonald's App during the Contest Period. Each completed order counts as one (1) entry submission. b. The more orders a participant places, the higher chances of winning the Prize. c. Only residents of Selangor or Kuala Lumpur are eligible to participate in this Contest. There is no limit to the number of entries submitted within the duration of the Contest. Only one (1) participant will be chosen as the winner and win the Prize once. The Organiser's decision on the winner is final. No further correspondence or appeal will be entertained.

8. Selection Criteria:	 In determining whether an entry is a valid entry, the Organiser's decision shall be final and conclusive. The Organiser will take into consideration all factors deemed relevant which may include but not limited to the following criteria:- Participants with the most number of valid entries will be the winner of the Prize. The Conditions of Entry and the Schedule to Condition of Entry shall collectively be referred to as the "Terms and Conditions". Each capitalized term not otherwise defined herein shall have the meaning ascribed to such term in the Schedule to Conditions of Entry. Defined terms will be used singular or plural as the case may be.
- 1.2 The Organiser reserves the right in its sole discretion, without prior notice, and without any liability to any person, at any time to change the Terms and Conditions including to change the Contest Period, make Prize substitutions, cancel, terminate or suspend the Contest in whole or in part. 3. Eligibility
